NOTE Pursuant to a scheme of arrangement under Sections 230 232 of the Companies Act, 2013 and its allied rules which has been approved by the National Company Law Tribunal, Kolkata Bench vide its Order dated 4th November 2019 and has become effective from 4th December 2019 and as part of an internal restructuring, erstwhile shareholding companies i.e. Vishnuhari Investments & Properties Limited (VIPL), Bhaktwatsal Investments Limited(BIL), Commercial House Private Limited (CHPL) have merged with Kothari Investment & Industries Private Limited (KIIPL). The investment and trading division of Kothari & Company Private Limited (KCPL) has demerged and transferred to the said KIIPL. Accordingly, the shares held by the said VIPL, BIL, CHPL and KCPL earlier, are now held by Kothari Investment & Industries Private Limited.
